The Sutter County Probation Department complies with the Board of State and Community Correction's Standards and Training for Corrections (STC) program requirements to insure professional competence of our peace officers on staff. The STC program establishes a statewide standard to raise the level of competence of the state's local corrections and probation personnel to support proficient job performance. All entry-level probation officers in Sutter County must complete an STC certified Probation Officer Core Course (POCC) within the first year of employment to meet the state standard for training set by STC. Pursuant to the STC program, 40 hours of annual training is mandatory for all sworn personnel that have completed core training. Annual training is specialized or refresher training that develops or enhances job-related skills. Flexibility is permitted in course content and method of instruction to meet changing conditions and local needs. Due to the complexity of job assignments, some staff may need training that far exceeds minimum state standards. Participating departments are encouraged to exceed the minimum training standards when necessary to realize the goal of increased job skills and competency.

The list below shows the various employment classifications eligible for STC participation and the minimum number of hours of annual training that must be attended subsequent to the completion of core training.

Journey Probation Officer: 40 hours Probation Supervisor: 40 hours

Manager: 40 hours

Administrator (Chief Probation Officer): 40 hours
