Sutter County Walnut Theft Prevention Ordinance

This letter is to inform you that on August 5, 2014, the Sutter County Board of Supervisors passed and adopted the Sutter County Walnut Theft Prevention Ordinance. The purpose of this ordinance is to establish requirements regarding the transportation and identification of walnut crops, including establishing a walnut buying period. It is the purpose and intent of this ordinance to establish a means of verifying ownership of specified agricultural commodities in order to prevent and deter theft of walnuts.

In brief:

- Walnuts transported directly by a grower from the farm or ranch where they
 are grown to a commercial processing or packing plant are exempt from this
 ordinance.
- This ordinance establishes a Walnut Buying Period. The Walnut Buying Period is declared by the Agricultural Commissioner upon the conclusion of harvest of the Chandler variety of walnuts. At that time, non-processing walnut buying operations within Sutter County may lawfully purchase and receive walnuts that have not been dried or processed. This buying period shall be proclaimed seventy-two (72) hours in advance by press release and shall remain in effect until April 30th of the following year.
- If a person in possession of walnuts is not the grower, they must have a
 completed Proof of Ownership certificate. The Proof of Ownership certificate
 shall remain with the walnuts until sold. Following any sale of walnuts, the
 proof of ownership certificate shall be retained by the buyer for a period of two
 (2) years from the date of each sale. A Proof of Ownership certificate
 approved by our office is attached for your use and posted on our website.

- If you buy, process or resell walnuts you may also be required to comply with the following:
- 1. Market Enforcement Branch license issued by the California Department of Food and Agriculture. http://www.cdfa.ca.gov/mkt/meb/forms.html
- 2. Weighmaster license issued by the Division of Measurement Standards. http://www.cdfa.ca.gov/dms/programs/wm/wm.html
- 3. Have a registered and sealed commercial scale on file by our office as required by Sutter County Ordinance Code Chapter 215.
