Sutter-Yuba Tsev Khomob Puashlwb Nyuajsiab muaj lus zoosiab thov qhia txog Prop.63, Tsev Khomob Puashlwb Nyuajsiab Rabcai. Uatsaug rau nej sawvdaws cov uas tau pabtxhawb rabcai tseemceeb no, tau dhau los ua ib rab kevcai lijchoj.

## Saibntxiv

Prop. 63, *Tsev Khomob Puashlwb Nyuajsiab Rabcai*, Cov nyiajse uas tau los ntawm ib tusneeg ua tau nyiaj ntau, yog cojlos pab California's county cov tsev khomob Puashlwb nyuajsiab. State ceg saibxyuas Tsev Khomob Puashlwb Nyuajsiab pomzoo yuav nrog county cov Tsev Khomob Puashlwb Nyuajsiab sibtham npaj tsimkho thiab dhia haujlwm kom tau nujnqe los txhawb Prop. 63. Nws yog ibqhov tseemceeb uas tsimnyog yuav tau paub tias thawj xyoo kev dhia haujlwm, yuav tsis tau txais nyiaj los pab. Rab kevcai lijchoj yuavtsum kom iblub county twg npaj ua ntaub-ntawv lub tswvyim yuav los tsimkho thiab xa 3-xyoo lub homphiaj cov ntaub-ntawv tswvyim tau npaj tseg thiab yuav tau ua li rabcai. State ceg saibxyuas Tsev Khomob Puashlwb Nyuajsiab xav kom txhua lub county cov tsev khomob puashlwb nyuajsiab muab cov nyiaj cojlos siv pab txhua haivneeg kom li state tau hais tseg. Txoj haujlwm yuav tau pab kom cov tibneeg xyaum ua tau neeg zoo/txaussiab nyob tau ibleeg, muaj kev ciasiab, saibxyuas tau yus tuskheej thiab cov tibneeg laus uas muaj mob puashlwb nyuajsiab heev, cov menyuam yaus uas

muaj mob nyuajsiab chimsiab heev, thiab lawv tsevneeg kom yuav rovqab sib raug zoo li qub. Sutter-Yuba Tsev Khomob Puashlwb Nyuajsiab xav muaj feejxyuam los npaj tswvyim pab cov tibneeg uas muaj mob puashlwb nyuajsiab thiab tsevneeg uas xav tau kevpab. Xav paub ntau ntiv losyog xav mus koom, thov hu tau rau Donna Thompson, Staff Analyst, losyog Paul Moua, Intervention Counselor I, at 822-7200.

## Lub Homphiaj thiab Txoj hauv kev Npaj Tseg ntawm Prop. 63

- Uantej tshajplaws yog cojlos pab rau cov tibneeg lausheev, cov laus thiab cov menyuam yaus uas mob puashlwb nyuajsiab heev thiab los tivthaiv tej kev mob puashlwb nyuajsiab uantej yuav mobheev thiab lawv yuav dhau mus ua tibneeg ua tsis tau dab tsis li lawm thiab nrhiav kev khomob pab rau lawv ua ntej.
- Xav kom tej kev pab no sai rau ibleeg twg, tsev tibneeg twg, thiab state thiab lubzos npaj muaj cov nyiaj yuav los pab rau cov uas muaj mob puashlwb nyuajsiab heev uas tseem tsis tau txais kev pab li.
- Nthuav qhia txog tej kev pab uas tau muaj pub rau cov menyuam yaus, cov laus thiab cov lausheev, nrog rau lwm haineeg uas tseem tsis tau txais kevpab thiab cov uas muaj mob puashlwb nyuajsiab heev.
- State thiab lubzos npaj cov nyiaj los pab them pub rau cov uas tsis muaj nyiaj them.
- Kom pabntseeb tias cov nyiaj no yuav cojlos pab them pub rau cov neeg uas tsis muaj nyiaj thiab ua kom tau zoo tshaj li qhov uas lubzos thiab state tseem pom tsis tau txog.

Rab kevcai lijchoj pomzoo kom yuavtsum siv 3-xyoo lub homphiaj npaj rau ib xyoo muab faib nyias muaj nyias:

- **10%** npaj kev cobqhia thiab kev kawm ntawv.
- **10%** rau capital cov chaw ua haujlwm thiab technology
- **20%** Npaj kev tivthaiv uantej pab rau cov neeg puashlwb nyuajsiab uas yuav mobheev thiab ua tsis tau haujlwm
- **5%** npaj pub rau tej pabpawg coob uas tseem tsis tau txais kevpab li, sib txhawb koom uake, thiab thiaj ua tau haujlwm zoo thiab tau txais kev sib pab zoo
- Cov nyiaj seem muab faib rau lubzos coj mus siv rau:
  - ⇒ Pab rau cov menyuam yaus muaj mob puashlwb nyuajsiab heev
  - ⇒ Pab rau cov laus thiab cov lausheev uas muaj mob puashlwb nyuajsiab heev
  - ⇒ Muaj khawscia npaj tseg yuav coj los pab siv rau cov homphiaj tshiaib thaum cov nyiaj lub xyoo dhau los ho tsis muaj txaus siv.

Tomqab 3-xyoo no xaus, cov nyiaj yuav tsis muab cojlos faib ua ntau pawg lawm, thiab yuav muab siv rau:

- Pab rau cov menyuam yaus, cov laus losyog cov lausheev
- Technology thiab capital cov chaw ua haujlwm
