4. MHSA Plan Update – Peter Sullivan, Staff Analyst, MHSA Coordinator:

Mr. Sullivan introduced himself and opened the floor for any comments on the MHSA Plan update and offered the following in response to questions:

- Funds that were not spent during the last fiscal year will now be spent to hire a peer mentor and possibly a data analyst for PEI, enhance services for the homeless outreach program, expand existing outreach contracts and provide workforce training. Funding being spent is one-time funding however other funding from the same source will continue for the next few years to keep services in place.
- ➤ Workforce Education Training classes will be held at behavioral health and through the vocational training program in conjunction with the Sutter County Superintendent of Schools. Training will be announced through several sources such as the county website, both county libraries and the newspaper.
- ➤ Yuba College Partnership goal is to create a partnership to help dispel misconceptions of mental and behavioral health issues and provide education on the resources offered by Sutter-Yuba Behavioral Health.
- ➤ Innovation Project currently researching projects to reduce stigma in rural communities. Plan is currently being written and will be brought back to the BHAB once draft is complete.

5. Program Update – Ethnic Outreach – Mai Vang, LCSW and Alex Barela, LCSW;

Ms. Vang introduced herself and Mr. Barela and provided the following updates for the Ethnic Outreach Program:

- Ethnic Outreach Services provides full range outpatient specialty mental health services (except medication services provided at the main building) to Hmong & Spanish speaking members of both Sutter and Yuba Counties. Services includes, but are not limited to triage, intake assessment, individual therapy, groups, transportation to mental health appointments for those who qualify, interpreting at psychiatry appointments, case management services, and referrals.
- ➤ The Latino Outreach Center (LOC) serves both adults and children who are Spanish-speaking only or bilingual in the Sutter and Yuba Counties who are not engaging in the general mental health services due to cultural and linguistic barriers.
- The Hmong Outreach Center (HOC) currently serve Hmong-speaking only/bilingual adults only, due to the limited numbers of youth and children enrolled in services. For children, the HOC works with children mental health providers by providing language and cultural accommodations to families when the parents are monolingual. In efforts to reduce mental illness in Hmong youth/children, the HOC also partners with the Hmong American Association, a local Hmong non-profit organization, to run a youth support group.
- For the HOC, many consumers have suggested and reported that the facility is too small for activities. While we have worked with realtors to find a new location, we have not yet found any due to the limited availability of buildings in the Olivehurst/Marysville area that suits and meets the HOC needs. Mental health stigma and lack of knowledge about mental health services continue to create barriers for the Hmong community since the concept of counseling does not exist in their culture.
- ➤ For the LOC, some of the difficulties experienced in providing these services have been the negative mental health stigma among the Latino population and the temporary disruptions with excessive caseloads on two separate occasions when therapists left due to family needs and retirement.
- For both Ethnic Outreach Services, some of the outcomes gathered and reviewed through client surveys and electronic medical records (EMR) reports are the following:
 - ✓ Meeting objectives of providing effective access to specialized mental health services to traditionally underserved Latino/Hispanic community in Sutter and Yuba Counties
 - ✓ High levels of client satisfaction
 - ✓ Decrease mental health stigma among Latinos
 - ✓ Provide wide range of services (levels of intensity, youth, adults, couples and families).
 - ✓ Consistent high demand for our services since Center opened 3 years ago
 - ✓ Collaboration with other SYBH programs and community organizations such as local medical facilities, schools, law enforcement agencies, public services offices, housing and churches.

6. Behavioral Health Director's Report - Rick Bingham:

Mr. Bingham reported on the following:

- > Psychiatric Emergency Services (PES) seen over 2,800 people in 2018; this has steadily increased over the last few years.
- ➤ PES is providing trainings to law enforcement on 5150 processes.
- ➤ PES is also piloting a temporary change for the night clinic located at 1965 Live Oak Blvd. Between the hours of 11:00 p.m. and 7:00 a.m. crisis services will not be provided at this address. Clients will be referred to crisis staff imbedded at Adventist-Rideout. Phone lines at 1965 Live Oak will still be answered 24/7.
- ➤ Forensics while all services related to psychiatric medication services have now transitioned to Well Path for the Juvenile Hall and Camp Singer, Forensics continues to staff two therapists at these sites.
- ➤ Children's Services Continuum of Care Reform is continuing to be implemented and staff continue to comply with this edict.
- ➤ Psychiatric Health Facility sprinkler install is scheduled to begin in April; installation will be completed in phases so the PHF will not have to totally shutdown as previously reported.
