Yuba City Unified School District (YCUSD) is requesting the following line item transfers for the 2018-2019 Smart Start Program Budget (see attached budget detail):

- \$15,000 from Certificated Salaries to Classified Salaries
- \$2,000 from Certificated & Classified Benefits to Classified Salaries

These line item transfers will also us to operate three Smart Start sites beginning on June 13th. In order to provide 20 days of instruction, the program end date will be July 12th, 2019. There will be two days off (July 4th & 5th) for the July 4th holiday. With this in mind, we are also requesting permission to use \$24,900 of the 2018-2019 grant funding (see attached budget detail) to cover the eight program days in July 2019:

- \$13,500 for Certificated Salaries July 1st-12th, 2019
- \$6,600 for Classified Salaries July 1st-12th, 2019
- \$4,800 for Certificated and Classified Benefits July 1st-12th, 2019

These line item transfers and budget extension are not a request for additional funding and **do not** change the overall grant amount for the 2018-2019 school year. Please let me know if the Sutter County Children and Families Commission requires any additional information to approve these line item transfers and budget extension.
