# 1) SUTTER COUNTY CHILDREN & FAMILIES COMMISSION VACANT SEAT RECOMMENDATION TO THE BOARD OF SUPERVISORS

Ms. Blake referenced the staff report contained in the meeting packet and noted 2 applications were received for the at-large member Commission seat. The applicants were Tom Reusser and Harjit Singh.

Commissioner Byers volunteered to lead the interview process and began the interview with Tom Reusser.

Commissioner Byers asked Mr. Reusser to introduce himself.

Mr. Reusser stated he is currently the Superintendent for Sutter County Office of Education. He is a lifelong resident of Sutter County and has held several positions with in the education system.

Commissioner Byers asked Mr. Reusser to share his background with working with children 0-5 years old.

Mr. Reusser noted in addition to being a father and grandfather, he has been a swimming coach and his office currently administers Countywide programs for infants and preschool age children.

Commissioner Byers asked Mr. Reusser to list personal strengths that fit with the Sutter County Children & Families Commission.

Mr. Reusser noted as Superintendent he has the opportunity to leverage knowledge and resources from other county Superintendents as well as, potential partnering opportunities at the local level.

Commissioner Byers asked Mr. Reusser's thoughts on what makes the Commission's mission powerful to him.

Mr. Reusser noted his desire to create many resources for young children and be an advocate for them.

Commissioner Byers asked Mr. Reusser if he had any personal aspirations about serving on the Commission.

Mr. Reusser noted his passion for being part of and serving the community as well as having the time to commit to the Commission.

Commissioner Gulbrandsen arrived.

Commissioner Byers asked the Commission if they had any additional questions for Mr. Reusser, no additional questions were asked.

Commission Byers asked Mr. Singh to introduce himself.

Mr. Singh stated he was born and raised in Sutter County, he has been a classroom teacher and is currently a Community Organizer for the Jakara Movement, a statewide nonprofit that works with the Punjabi community.

Commissioner Byers asked Mr. Singh to share his background with working with children 0-5 years old.

Mr. Singh stated he has experience with organizing family events and communication with parents of children 0-5. Mr. Singh also noted his experience in organizing camps and workshops focusing on youth leadership development and community engagement.

Commissioner Byers asked Mr. Singh to list personal strengths that fit with the Sutter County Children & Families Commission.

Mr. Singh stated his community engagement skills and a representative of the Punjabi community are his strengths.

Commissioner Byers asked Mr. Singh's thoughts on what makes the Commission's mission powerful to him.

Mr. Singh noted the importance of early childhood education as a tool to improve outcomes for children.

Commissioner Byers asked Mr. Singh if he had any personal aspirations about serving on the Commission.

Mr. Singh noted his community engagement experience and desire to work with families to emphasize the importance of early childhood education.

Commissioner Byers asked the Commission if they had any additional questions for Mr. Singh, no additional questions were asked.

The Commission held a lengthy discussion around the Commission's current cultural and occupational makeup. Commissioners noted both applicants' passion for children and families in the community and experience.

The Commission discussed the at-large member seat recommendation process. Ms. Blake noted the process to recommend an applicant to the County Board of Supervisors in a public meeting for final appointment was directed by County Counsel. Ms. Blake noted the Commission has gone through the recommendation process several times. Commissioner Byer stated she has gone through the process two times. Commissioners asked Ms. Blake to follow-up with County Counsel regarding the process.

On motion of Commissioner McIntire, seconded by Commissioner Garcia and carried as follows: AYES: Commissioners, McIntire, Garcia, Gulbrandsen, Osumi, Byers; ABSTAIN: None; NOES: Commissioner O'Hara; ABSENT: Commissioners, Whiteaker, Patton; the Commission motioned to put forth both qualified applicants to the Board of Supervisors and for the Board of Supervisors to appoint one applicant to the at-large member seat on the Sutter County Children & Families Commission.
