Fish and Wildlife Warden Update – No report.

Commissioner Comments— (Various Topic and discussion)

-Sportsman's Expo January 16-19- Stone NCGASA.org. Conversation about Article saying hatchery fish inferior to wild and should be killed. 1.3 million adult salmon returning and 800 thousand are killed unspawned at the fish ladders. Since 1996 State of California giving away fish after spawning capacity reached, to American or Canadian fisheries up north. Loaded in trucks and given free. (Oregon and Washington are paid approximately \$0.18 per pound but California gives the fish away due to the commute of refrigerated trucks sent here. Eggs are sold for millions and fish are filleted and given away, most recently in Oroville, 7 fillets salmon per person. Started 18 years ago, contract signed by Governor. This information was presented last march to the current Director, Chuck Bonham (Affiliated with Trout Unlimited), was disregarded as he wants to shut down hatcheries after dams are removed. Per commissioner comment, Bonham doesn't like hatcheries, considers hatchery fish inferior despite millions surviving and returning the same as wild fish. Regular maintenance not being done, Feather River one of the worst offenders. Hatcheries are partially federally funded, haven't gone over the State's head on this matter yet but is possibility.

- -Additional notes regarding Hatchery fish: Potentially set up a booth at the State Fair showing the mismanagement of fisheries. Would be a good platform to share a presentation. Last time a booth at the State Fair cost \$3-400, need to find out if missed the cut-off. *Agendized.
- -April 18-19 Striper Fishing Derby in Colusa, large prizes
- Disabled Veterans Pheasant Hunt February 16, 2020 at Quail Point (Attachment forward to Board of Supervisors)
- -Mosquito Beach/YC Boat Ramp lots of garbage, can a cleanup be organized? Homeless still an issue (Can ask someone from County Homeless Committee to attend next F&G meeting and speak regarding cleanup projects?) Recology will take trash free from community cleanups. Possibly include other groups, fishing tour guides, get more people, make bigger statement. Jeff Stephens (Stephen's Farmhouse/SAYLove) and Jerry Handy running 4G Foundation; had discussion about community project and SAYLove got a free truck/dumps from Recology.

-Next Month (February 24-27, 2020), Hunter Ed at Ag Department, 6-9pm. 40 Students signed up.

Public Comments— Dale Whitmore spoke with Bob Buckner at General Services about the drop off at the end of the Yuba City Boat Ramp. Will need to be addressed with Department Boating and Waterways (Stream Bed Alteration)

-Date Whitmore, Public access in Marysville at Riverfront park. Where signs used to say, "No Parking", now way "Day Use Parking". After many city council meetings got change done until after April when they are re-doing the levee. State fishing license sales down 55% since 1980. 1.3 million anglers per 40 million population. 260,000 hunting licenses (Less than 2% of the population), but 14% of population own guns. CDW hired a full-time person to recruit new, young hunters to get them outdoors.

-Also, discussion of issue at Sheriffs Training Center- Homeless blocking the road
