- A. Commission Hunt- Chuck Wyllie: No Report
- B. **Boat Ramp- James Stone:** Tisdale boat ramp is undergoing major repairs, debris removed, boulders and river rocks to protect. (Who paid for work on Tisdale?). Yuba City boat ramp experiencing large # of break-ins (3 known in 10 days). Homeless are lining 2<sup>nd</sup> Street. One porta potty from Ben Toilet at Yuba City Boat Launch not keeping up with traffic/service.

- C. **Education- Robert Ripley:** Still working on WILD program and Duck Camp with CWA. Talk with Superintendent of Schools, waiting to hear back, possibly a summer camp
- D. Conservation- Bruce Hutchinson: No report.
- E. Special Projects- Chuck Wyllie: No report.
- F. **Planning & Budget- Danarae Doub-Reed:** If you want any changes please email Danarae, County needs information by February.
- G. **Fishing Committee- James Stone:** Salmon release numbers are looking good, was told the numbers are increasing and population looks healthy. Possible ocean restrictions next year on Salmon relative to humpback and killer whales. Oceanus (?) suing Dept of Commerce- threats from crab pots, nets, boat motor noise. Rope-less crab pots suggested but show approximately 30% failure in recovery. Southern resident whales suffering head malformations due to lack of amino acids in hatchery fish, or the whales just don't eat them. Reference to Patagonia Movie "Artifishal" about hatcheries. Red sea urchins killing kelp/abalone.
