Licensing Requirements for Maintenance Gardeners

Many of us have lawn care professionals that mow our lawns and trim our trees; but did you know that if they use Roundup or other pesticides they need to be licensed and registered with our office?

All maintenance/landscape gardeners that apply pesticides or herbicides must have a Qualified Applicators License/Certificate through DPR, have a Pest Control Business License, and be registered with the county in which they work.

Employees of these businesses are required to wear all of the proper personal protection equipment as well.

Please help your landscape gardener out. Have them come to our office where we can get them applications and show them where to find study material.


Dormant Spray Regulation Overview

As winter approaches, you may decide to use a dormant spray in your orchard.

New regulations regarding dormant sprays were released in 2006. These regulations have several requirements that must be met prior to any dormant application. These requirements include:

- no applications made within 48 hours of rain event or if your field is saturated with water.
- recommendation from your Pest Control Advisor
- do not apply within 100 feet of a sensitive aquatic site (ditches, canals, etc.)
- wind speed must be between 3-10 mph

NEW Respirator Requirements

Last year, California Code of Regulations (CCR) 6739 went into effect for all employees who are required to wear respiratory protective equipment.

CCR 6739 requires all employees to have a medical evaluation and be fit-tested prior to using any respirator, this includes dust/mist respirators. The medical evaluation needs to be evaluated by a medical professional. The questionnaire is available at our office and can also be found on our website.

Common Problems in 2008

After reviewing our 2008 inspections, we discovered many common problems. The following is a list of these more common noncompliance items.

- Orchard posting requirements for Lorsban (48 hours), Penncap (25days) and Omite (21 days)
- Label required water holds in rice fields for Shark (30days), Cerano (14 days), and Grandstand (20 days)
- Chemical resistant apron label requirement for Stam 80EDF
- Accessibility to personal protection equipment when your employee is in an enclosed cab
- Emergency Medical Posting availability at worksite
- Timely submission of Pesticide Use Reports
- Submission of Use Reports for herbicide strip spray
