### 2012 Problems

In 2012, Pesticide Use Enforcement staff conducted approximately 330 pesticide use inspections, field worker inspections and record audits. During these inspections, we observed several reoccurring non-compliances involving worker safety issues and paperwork/documentation violations. While these problems are not new, they do represent an overall picture of inadequate employee training. Examples of the violations documented in 2012 include:

- Lack of personal protection equipment (safety glasses, coveralls, chemical resistant gloves, rubber boots)
- Access to decontamination facility (soap, water and towels) at the mix/load site
- Emergency Medical Posting (name, address and phone number of emergency facility) at the worksite
- Availability of pesticide label at worksite
- Documentation of annual employee safety training
- Monthly submission of Pesticide Use Reports

As in past years, we will be offering a variety of training classes for both you and your employees to attend in order to be safer and more efficient in pesticide related activities.

#### **Electronic Pesticide Use Reporting**

CalAgPermits is the new web-based permitting system used throughout the State to ensure consistent and accurate issuance and submissions of restricted materials permits and pesticide use reports. Late use reports are a problem for both growers and the County, late reports can generate notices of violation and possible fine actions for growers who routinely turn in late use reports. CalAgPermits gives growers the ability to access their permits and submit use reports from home. The online versions of these reports look identical to the old paper versions, and can be printed when needed. This service is free of charge and easy to use. By creating a webuser account with the County, you will have access to a pesticide use report submission page, a notice of intent submission page, a complete history of all reported pesticide usage for each site and printable maps of your sites. This free service is also available for pest control businesses. As a reminder, pesticide use reports for growers are due by the tenth of the month following the date of application. If you strip spray Roundup on January 4th; your report will be due on February 10th. Pest control businesses need to have their reports submitted to the County within seven days of the application and submit a copy to the grower within 30 days. There are four different ways to submit your use reports to Sutter County:

- CalAgPermits allows users to create a unique online web account in order to submit use reports and notices of intent as well as review previously submitted reports.
- Software vendors such as AGRIAN or CDMS can be used to submit use reports. These programs download your permit and allow online submissions.
- Chemical dealers may submit use reports to the county on your behalf. However, the applicator is ultimately responsible for the timely submission of these reports.
- Hand written use reports can still be submitted using the approved state forms. We accept reports either by mail, in person or at the PUE drop box. We do not accept faxed copies.

## **Employee Training**

Annual safety training for employees that handle pesticides is required by law. Training topics include: pesticide labels, hazards, routes of exposure, symptoms of overexposure, emergency medical care, decontamination procedures, personal protection equipment, safety requirements, environmental concerns, medical supervision, PSIS "A8" and MSDS locations, and employee rights.

Prior to employees handling pesticides, a hazard communication program and advanced emergency medical care must be in place. A hazard communication program includes the Pesticide Safety Information Series, pesticide use records and MSDS. Advanced emergency medical care planning information shall be posted at the worksite.

Proper documentation is essential for an effective training and hazard communication program. Always have your employee sign and acknowledge the training and keep this paperwork for at least two years. Update and compile your MSDS on an annual basis. Pesticide use records should be current and available for review.

## Willow Primrose (Ludigia decurrens)

Ludigia decurrens, otherwise known as Willow Primrose, is an invasive rice weed previously only found in Texas and the Midwest. For the past two years it has been found in the Richvale area of Butte County. Ludigia can grow up to six feet tall and has small yellow flowers with four petals. The most prominent feature of Ludigia is the seed box located below the flower. This seed box contains a large amount of seeds. The distinctive stem of Ludigia has four

wings which run the length of the plant. *Ludigia* can propagate by seed and by plant fragments. It is recommended that plants be controlled through herbicides or by rogueing. If you see *Ludigia*, please contact the Ag Depart-
