Reasonable advance telephone notices of entry shall be given, to the extent feasible, or as otherwise authorized by law. To the extent reasonably necessary to verify that the IH contains less than 0.3% Total THC, IH Licensees consent to additional testing by enforcement officials, which shall be at the cost and expense of the Licensee. I acknowledge that failure to destroy a IH crop, as required, shall cause forfeiture of the financial security provided. The County may enforce this provision using all remedies provided by law, including the application of Administrative Penalties on the property where the cultivation or processing of IH is occurring.
