- 1) Discussion and action (Continued) Requirements and location for potential Sutter County Public Rifle Range.
 - a. Rick Libby talking with people regarding using the Quarry in Sutter as a possible location. Talk to Mike Ziegenmeyer, will set up meeting with Butte Rock and Gravel. County could possibly lease quarry until such time as the owners want to reopen it. If can secure the locations possibly bring in Colusa County as well.
 - b. In other counties Parks and Rec runs boat ramps, gun ranges etc. Chuck to talk to Bob about that.
 - c. Continue to next meeting.
- 2) Discussion and action-- (Continued) New Location options for Commission Hunt
 - a. Talked to Dave- Had to send request to use Gray Lodge up the chain of authority for approval. Likely will not go through.

 - c. James Stone will coordinate with "SayLove" for a clean-up day at the boat ramps. Last Saturday of each month they do a cleanup and lunch.

Commissioner Comments— Danarae briefed on Disabled Veterans Hunt, February 16. Lot of volunteer vets. Yuba Sutter Stand Down brings a lot of gear and hydration freebies. James Stone briefed on his Hunter Safety Class, first class as instructor. Comment that DFW at some point may have to make political decisions regarding wardens, fishing, hunts, etc. Pacific FM advisory in Santa Rosa- 8 days, Oregon, Washington, California and Idaho reps, shape the ocean season for the west coast. Pcouncil.org. Salmon to start 4/11 in SF and Fort Bragg, the rest to be determined at the April meeting. Highest count of Sacramento River salmon since 2013, low number for Klamath (Coastal Chinook) Cresent City to the Oregon border not much fishing available. Discussion regarding fish migration routes and counts. July 16 river opening for Salmon. Discussion regarding 2% California residents are hunters compared to 14%-gun owners. Most registered to men. How to focus on women as hunter/gun owners +/- 35% participants in hunter ed-women.
