 - a. Explanation of the committee purpose was given. Group was notified that the committee is now full. Committee will meet once per year, as needed for plan adjustments.
- V. Review and Approve SB 823 Plan Donya Thompson
 - a. Donya provided an update: building is still being remodeled, but programs are in place. Subcommittee meets at lease monthly. 1st youth belongs to Colusa County. Donya reviewed the plan with the group. Amanda asked for clarification regarding first paragraph on page 7. Nicole called for any additional questions or comments. Explained that this meeting will reconvene annually to adjust the plan as necessary. Noted that a gang program will be included in the future. Paula asked if we are looking to contract for those services. Donya explains that we can facilitate this addition to the plan through staff, but gang counseling may be contracted out. Amanda asked for more explanations included under Residential Intervention bullet points. Nicole requests any other suggestions. None were given. Motion by Amanda Hopper to approve the plan. Seconded by Carrie Bevacqua. Unanimously carried. Motion passes.

 - a. Nicole explains that the grant received was more than originally anticipated. This will pay for a new roof, repainting, needed furniture, and fencing.
