March 5, 2024

Polls open at 7:00 am and close at 8:00 pm

Offices up for election requiring a filing fee:

US Rep in Congress, US Senator, State Assembly, State Senate, State Constitutional Offices, County Offices, Judge Superior Court Depts 5 & 6, and Supervisor Districts 1, 4 & 5.

Sept 14 – Nov 8, 2023 (E-173 - E-118)	Signature in Lieu of Filing Fee , signatures can be obtained at this time to satisfy the filing fee in full or in part. These signatures can also be applied to the nomination signatures. EC 8061, 8105, 8106
Oct 30 – Nov 8, 2023 (E-127-E-118)	Judicial candidates file Declaration of Intent (Judicial Candidates only); candidate filing fees are paid when this document is filed. EC 8023 and 8105(b)
Nov 9 – Nov 14, 2023 (E-117-E-113)	Declaration of Intent extension (Judicial Candidates only) is granted for non-incumbents if an incumbent judge does not file a Declaration of Intent. EC 8023
Nov 13 – Dec 8, 2023 (E-113-E-88)	Filing of Declaration of Candidacy and Nomination Papers for all candidates, and candidate statements (200 words or less) State candidates (250 words) due also. EC 10510, 13307 Candidate Statements may be withdrawn but not changed by 5pm next working day after close of nomination period. EC 13307(3)
Dec 9 – Dec 13, 2023 (E-87-E-83)	Extension of nomination period (<u>only</u> for non-incumbents if an incumbent does not file.) EC 8024
Dec 14, 2023 (E-82)	Random Alpha Draw 11 a.m. EC 13112
Jan 8 – Feb 20, 2024 (E-57-E-14)	Write-In Candidate Filing Period EC 8601
Feb 5, 2024 (E-29)	Vote by Mail Ballots Issued EC 3001, 3003
Feb 19, 2024 (E-15)	Last Day to Register to Vote for this Election EC 2107
Mar 5, 2024 (E)	Election Day – Polling Places open, 7:00 a.m. - 8:00 p.m.
