## **NOTICE OF PUBLIC HEARING**

Notice is given that at **6:00 p.m. on Wednesday, September 20, 2023,** in the **City of Yuba City Council Chambers, 1201 Civic Center Boulevard, Yuba City, CA,** the Sutter County Planning Commission will hold a public hearing on the following:

Project #U22-0013 (Platinum Express, Inc.) – A Use Permit for a large general truck yard for a maximum of one-hundred twelve (112) trucks and trailers along with repairs and maintenance; AG (Agriculture) District; located at 7235 Pacific Avenue, Pleasant Grove, CA 95668, on the west side of Pacific Avenue, 1.5± miles north of Riego Road and 0.5± miles south of Sankey Road; APN: 35-220-017; Applicant/Owner: Platinum Express, Inc. (A Mitigated Negative Declaration is proposed)

**Project #U22-0033 (TeleSpan Communications, LLC)** — A Use Permit for a new wireless telecommunications facility that will include a freestanding 125-foot tall monopine tower and associated ground-mounted equipment contained within a 50-foot by 50-foot (2,500 square foot) screened enclosure at the base of the tower, all within a 70-foot by 70-foot (4,900 square foot) ground space lease area; P (Public) District; located at 2665 Acacia Avenue, Sutter, CA 95982, northwest of the intersection of Griffith Lane and Acacia Avenue; APN: 13-200-128 (lease area) and 13-200-129 (access); Applicant: TeleSpan Communications, LLC, Owner: Sutter Union High School District. (A Mitigated Negative Declaration has been prepared)

<u>Project #U22-0006 (Thiara)</u> – A Use Permit and Design Review to establish a large general truck yard for a maximum of eighty-one (81) trucks and trailers; M-1 (Light Industrial) District; located at 17812 State Highway 113, Robbins, CA 95676, on the east side of State Highway 113 and the west side of Reclamation Road, within the Rural Community of Robbins; APN: 29-080-007; Applicant: Sarbjit Thiara, Owner: Capital Farm & Management Company (A Mitigated Negative Declaration is proposed)

**Project #U23-0022 (Helm)** – Two-year time extension request for an approved tentative subdivision map (Project #U-19-031); ER (Estate Residential District); located on the north and south sides of Butte House Road, between Oak Street and Mallott Road in the rural community of Sutter, CA; APN(s): 13-240-112, 13-240-113, 13-260-033 and 13-260-040; Applicant: Helm Properties, Jeffrey T Helm. (Project is exempt from CEQA)
