- ➤ Ms. Esemann will change the response of "monthly" to "more than once a month" for the stakeholder engagement meetings discussed on page 25.

- 5. Program Presentation Homeless Services and Better Way Shelter Ms. Ymelda Mendoza-Flores. Ms. Mendoza-Flores reported on the following:
 - ➤ Housing First Approach People experiencing homelessness should be returned to or stabilized in permanent housing as soon as possible and connected with the resources required to sustain that housing. Underlying issues are best addressed after the person is in a stable housing environment.
 - ➤ Better Way Emergency Shelter
 - ✓ Temporary shelter for Sutter County residents ages 18-years and older.
 - ✓ 40-bed capacity with two beds reserved for Sutter County residents discharged from the Sutter-Yuba Psychiatric Health Facility.
 - ✓ Start to Finish was launched in July 2022 supportive services provided through the HEART team this program stays with the individual throughout their entire process.
 - ✓ Served approximately 500 homeless individuals.
 - ✓ Permanently housed 163 individuals.
 - ✓ Approximate length of stay is 59 days maximum length of stay is 90 days.
 - ✓ Behavior based low barrier shelter, drug, and alcohol-free campus with a curfew in place.
 - ✓ Case management and housing mitigation resources are part of the program.
 - ✓ Exit plan is developed to address sustainable housing, income, primary care physicians, food resources, budgeting, transportation, and referrals for services.
 - ➤ Harmony Village
 - ✓ 62-unit permanent supportive housing project for low-income Sutter County residents.
 - ✓ Prioritizes veterans, individuals with a disability and those 55 years of age and older
 - ✓ Opened December 2020 with 13 individuals housed. Currently occupancy level is 29.
 - ✓ Case management includes coordinating mental health and substance use treatment, establishing medical/dental care, income, or social security disability, assisting with basic life skills and various classes/activities are offered.
 - ✓ Community garden is available for those who want to participate.
 - ✓ Supportive services vaccination clinic, diabetes and nutrition education are provided by Sutter County Public Health.
- 6. MHSA Program Update Betsy Gowan, Brand Director, Adult Services
 - ➤ MHSA plan above will be taken to both Sutter/Yuba Board of Supervisors for approval hopefully by the end of the year.
- 7. **Behavioral Health Director's Report** Rick Bingham, HHS Assistant Director and Local Mental Health Director reported on the following:
 - ✓ HHS Outreach Flyer- event to be held on November 16, 2023, from 5:30 7:30 at the Sutter County Library Introduction to Health & Human Services.

- ✓ Consumer Party event is scheduled for Thursday, December 14, 2023, from 4:00 7:00 p.m. at Veteran's Hall.
- ✓ SB326 Governor has signed and will be on the ballot in March as Proposition 1.
- ✓ SB43 opens conservatorship up to individuals with substance abuse issues implementation can be delayed to January 2026 with a resolution from both counties' boards of supervisors which SYBH will be pursuing.
- ✓ PHF Fencing scheduled to begin on November 21, 2023 should take a little over a week.
- ✓ Ligature Points/Parking Lot Sump Pump funding has been approved by the Board of Supervisors. No start date has been set at this time.
