APPLICATION AND AGREEMENT FOR VOTER REGISTRATION INFORMATION
(EC 2167, 2184, 2185, 2188, 2194, 18109 and GC6254.4)

Pursuant to section 2188 of the Election Code, I hereby apply to the Sutter County Registrar of Voters to view, purchase, or use voter registration information currently on file. No refunds will be issued. Two (2) indices or one (1) file with no vote history are provided to Central Committees at no cost, at PRIMARY/GENERAL ELECTIONS and must be accompanied with a written request by the chairperson. (EC2185) The voter registration information set forth in affidavits of registration or derived from computer terminals, or discs, and/or computer printed listings will be used only for election, scholarly, journalistic, political, or governmental purposes as determined by the Secretary of State. EC 2194 (a)(3). Information furnished on this application is subject to verification.

AGREEMENT: The Applicant agrees that the information set forth in Affidavits of Registration of Voters and any information derived from said electronic data processing information (hereinafter collectively referred to as "registration information") will be used **ONLY FOR ELECTION OR GOVERNMENTAL PURPOSES**, or research as defined by Title 2, Division 7, Article 1, Section 19003 of the California Code of Regulations, and Elections Code Section 2194 and Government Code Section 6254.4.

The Applicant (as principal or agent) further agrees NOT to sell, lease, loan or deliver possession of the registration information, or a copy thereof, or any portion thereof, in any form or format, to any person, organization or agency without first submitting a new application and receiving written authorization from the Secretary of State to release such registration information. WILLFUL VIOLATION OF THESE PROVISIONS IS A MISDEMEANOR (EC 18109)

In addition, subject to provisions of Title 2, Division 7, Article1, Sections 19001 through 19007 of the California Code of Regulations, the Applicant agrees to pay to the State of California, as compensation for any **UNAUTHORIZED USE OF EACH INDIVIDUAL'S REGISTRATION INFORMATION**, an amount equal to the sum of fifty cents (\$.50) multiplied by the number of times each registration record is used by the Applicant in an unauthorized manner.
