NOTICE OF PUBLIC HEARING

Notice is given that at 6:00 p.m. on Wednesday, August 21, 2024, in the City of Yuba City Council Chambers, 1201 Civic Center Boulevard, Yuba City, CA, the Sutter County Planning Commission will hold a public hearing on the following:

<u>Project #U24-0022 (Sohal)</u> – a resubmittal of a previously approved Tentative Parcel Map (Project #U-20-018) to divide a 40-acre parcel into a five-acre homesite parcel and a 35-acre agricultural parcel; located at 11877 Larkin Road, Live Oak, CA 95953; APN: 09-010-043; Applicant/Owner: Joginder Sohal. (**Previously Adopted Negative Declaration**)

<u>Project #U23-0010 (Siller)</u> – a request for a General Plan Amendment from Agriculture, 40-acre minimum (AG-40) to Industrial/Commercial (I/C) and a Rezone from Agriculture (AG) to Commercial Industrial (CM) for a ±5.46-acre parcel located on the east side of Acacia Avenue approximately 0.4 miles north of State Highway 20, within the Rural Community of Sutter; 1493 Acacia Avenue, Sutter, CA 95982; APN: 13-270-087; Applicant/Owner: Andrea Siller 2021 Irrevocable Trust c/o Neal Siller (A Mitigated Negative Declaration is proposed)

<u>Project #U23-0024 (Chesney)</u> – a request for a Tentative Parcel Map to divide a 160± acre parcel into a 1.51± acre homesite parcel and a 158.49±acre agricultural remainder parcel in the AG (Agriculture) District; located at 250 South Meridian Rd, Meridian, CA 95957; APN: 13-160-001; Applicant/Owner: Robert C. Chesney Jr. Revocable Trust & Donal Chesney. (A Negative Declaration is proposed)

<u>Project #U23-0030 (Sangha)</u> – a request for a Use Permit to establish a Large General Truck Yard with a maximum of 76 trucks/trailer parking spaces on 5± acres in the AG (Agriculture) District; located at 8709 S George Washington Blvd / State Hwy 113, south of Tudor Rd and north of Thompson Rd, within the unincorporated area of Sutter County, Yuba City, CA 95993; APN: 25-030-004; Applicant/Owner: Jaskaran Sangha / Sangha Family '22 Trust and Bains Revocable Living Trust. (A Mitigated Negative Declaration is proposed)

<u>Project #U22-0036 (South Sutter LLC)</u> – a request for various entitlements to refine Phases 2 & 3 of the Lakeside at Sutter Pointe project, including: a Rezone, Large Lot Tentative Subdivision Map, and Small Lot Subdivision Maps for 485± acres within the Sutter Pointe Specific Plan area in Pleasant Grove / Elverta; APN: 35-170-003 & -092, and 36-030-001 & -002; Applicant: South Sutter LLC c/o Larry Gualco; Owners: L Street Land LP, Lennar South Sutter LLC and Riego 1700 LLC c/o Larry Gualco and TDW Enterprises c/o George Carpenter (Addendum to the Prior Adopted 2009 Sutter Pointe Specific Plan EIR)
