WHEREAS, on March 13, 2003, the Sutter County Board of Supervisors adopted the Natomas Basin Habitat Conservation Plan (NBHCP), Implementation Agreement, Environmental Impact Report (EIR) and Findings of Fact and Statement of Overriding Consideration; and

WHEREAS, the City of Sacramento, a NBHCP signatory, also adopted the Natomas Basin Habitat Conservation Plan (NBHCP), Implementation Agreement, Environmental Impact Report and Findings of Fact and Statement of Overriding Consideration; and

**WHEREAS**, the NBHCP Implementation Agreement, adopted concurrently with the NBHCP, requires the NBHCP plan signatories to fund the plan's operating program through the collection of fees that are adjusting annually; and

WHEREAS, annually the Natomas Basin Conservancy, as Plan Operator, is required to recalculate the NBHCP Finance Model and make a recommendation to the Plan signatories as to the fee necessary to successfully implement the NBHCP; and

**WHEREAS**, the Sutter County Board of Supervisors has determined it is appropriate as part of the implementation of Sutter Pointe, to update the mitigation fee to fund the Plan's operating program through the collection of fees pursuant to the Natomas Basin Conservancy's Resolution approved December 6, 2023, and 2024 NBHCP Finance Model; and

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of Sutter, updates the Natomas Basin Habitat Conservation Plan Mitigation fees as contained in Exhibit A and that the fees set herein shall become effective on April 27, 2024.
