Nomination period is July 15, 2024, through August 8, 2024, from 7:00 am - 3:30 pm, and August 9, 2024, from 7:00 am - 5:00 pm. Should the incumbent fail to file by 5:00 pm on Friday, August 9, 2024, the nomination period for that contest will be extended to August 14, 2024, by 5:00 pm for non-incumbents.

In the event there are no nominees or an insufficient number of nominees for an office and a petition for election is not filed with the Elections Office, appointments will be made.

Ballot processing may begin on the 29th day before the election. All procedures are open to the public and all interested parties will be afforded the opportunity to observe the process. Ballots will be tallied at the Sutter County Elections Office, located at 1435 Veterans Memorial Circle, Yuba City, CA 95993, beginning at 8:00 pm on November 5, 2024.

Polling places will be open from 7:00 am to 8:00 pm on Tuesday, November 5, 2024. The Elections Office will be open at 7:00 am to 8:00 pm on Tuesday, November 5, 2024. Please call 530-822-7122 for additional information.
