4. Action Items:

a. **Approve June 13, 2024, Meeting Minutes** - Member Cardoza moved to approve the June 13, 2024, Meeting Minutes as submitted. The motion was seconded by Member Page.

- 5. **Program Presentation** LPS/FSP Conserved Services Betsy Gowan, Branch Director, Adult Services presented on the following:
 - Senate Bill 43 signed into law October 10, 2023 goes into effect January 1, 2026 county is still working on infrastructure to implement this bill.
 - This bill expands California's criteria for involuntary detention and conservatorship which is based on a person's mental health disorder or severe substance use

- disorder, including alcoholism, resulting in the person's inability to provide for their basic needs for food, clothing, shelter, personal safety or necessary medical care.
- "New" definition for Grave Disability under SB 43 is a condition in which a person, as result of a mental health disorder, severe substance use disorder* or a co-occurring mental health disorder and severe substance use disorder, is at risk for serious harm or currently experiencing serious harm as a result of being unable to provide for their basic needs of food, clothing, shelter, personal safety* or necessary medical care*.
- Functionally, SB 43 allows people to be placed on 5150's and other involuntary holds based on their "severe" substance use disorder (SUD). This document provides a working definition of how severe SUD may be defined.
- A person with a 'severe' diagnosis would need to meet 6 or more of the 11 DSM criteria in order to be placed on a 5150 hold.
- Discussion on how a person is detained for necessary medical care or personal safety elements under the new rules could include unwillingness to eat when food is provided; irrational beliefs about food that is available (e.g., a belief that it is poisoned); inability to articulate a plan for getting food; unwillingness to clothe oneself when clothing is provided; unable to utilize shelter when provided or to formulate a reasonable plan for shelter.
- As of September 5, 2024, Sutter County has 41 LPS conserved individuals; Yuba County has 47.
- 6. **MHSA Program Update** Betsy Gowan, Branch Director, Adult Services. Ms. Gowan reported on the following:
 - Annual Update for 25/26 has been posted public comment period is open from September 9, 2024, through October 9, 2024. Public Hearing to be held during October 10, 2024, BHAB meeting.
- 7. **Behavioral Health Director's Report** Rick Bingham, Assistant Director of Health & Human Services and Behavioral Health Director. Reporting on behalf of Mr. Bingham, Ms. Gowan reported on the following:
 - 301 participants for Bridging Hope event.
 - Resolution to assess Sutter-Yuba Bi-County structure will be on Yuba County agenda on September 10, 2024, and Sutter County on September 24, 2024.
 - Mobile Crisis implementation has been delayed to the end of November 2024.
 - Recovery Happens Picnic held September 12, 2024 70+ vendors participated. Suggestion was for BHAB members to have shirts identifying them as BHAB members for events such as these.
 - CalAIM Justice Involved Yuba County Jail will go live with this on October 1, 2024 collaborative effort between multiple agencies. One of three counties in the state to go live on this date. Sutter County should go live some time around April 2025.
 - SYBH New Logo was rolled out on July 1, 2024.
